## **NATURAL RESOURCE ECONOMIST**

The Southern African Wildlife College is seeking to recruit a highly motivated person to develop the SAWC's capacity to teach wildlife economics, and to work on economic issues with the private, state and especially the community (CBNRM) sector.

The Economist, together with the CBNRM Manager, will build models and pilot sites that demonstrate how to involve communities (on both communal land, and land claims) in the wildlife sector in a meaningful manner, in order to reduce poverty at household level.

The Resource Economist will be expected to work with the private sector, protected areas, and communities to analyse working economic models, options and issues.

He / She will need to construct databases assessing R/ha returns to land from these models, as well as databases of prices for hunting and tourism aimed at assisting communities and protected areas to become financially viable.

He / She will also be expected to position the SAWC Economic Unit for further growth in supporting the inclusion of communities in the wildife sector in South Africa and beyond, including the reduction of illegal wildlife trade (mainly rhino).

The SAWC offers a competitive cost-to-company remuneration package (R 26,000.00 – R 32,000.00 pm, dependent on skills and qualifications), and the position will be on a rolling fixed term contract.
